#### Call to Order (8:20)

Welcome to the 89<sup>th</sup> annual convention of The American Bandmasters Association! I could not be more excited to welcome you to the nation's capital for our annual gathering. As many of you know, our first Washington DC convention occurred in 1932, when our organization was only three years old, and while the ABA has convened in DC several times over the course of its history, it has been more than three decades since our last Washington convention. Back in 1992, a much younger version of Nancy and I were serving as members of "The President's Own," when we learned that Col. John Bourgeois, Director of the Marine Band and President of the ABA, would be hosting a convention here in DC. I was serving as principal euphonium at the time, and was delighted to learn that I would be playing in a joint armed forces ensemble that would be performing at Constitution Hall. Among the many guest conductors for that concert was my college band director and ABA Past President Dick Strange, and although I didn't know it at the time, it would be the last opportunity I had to play under his baton. Nancy was working in our public affairs office at the time, and was integral to the registration and hospitality side of the convention. Little did we know then that 32 years later we would be "getting the band back together," so to speak, but we are delighted to be recreating some history this week! Nancy and I have the honor of co-hosting the convention with Jason and Lydia Fettig, Don and Laura Schofield, and Ken and Amy Collins, all of whom have been critical to the planning and execution of this week, and with whom it has been an absolute pleasure to work. I should also mention that although Andy and Heather Esch were involved in the early planning of the convention, they are unable to attend due to family obligations.

There's a strong likelihood that we may not be able to drop off as close to the Library of Congress as we had planned, so please bring your most comfortable walking shoes and as much patience as you can muster.

You may have noticed that there is limited space in front of the hotels, so boarding buses for our excursions may not always work exactly the same way. Please watch for guidance, and understand that we need to fill each coach to capacity when possible. There is no standing allowed. Once a coach is full, we will send it on to the site in order to bring another coach into position.

If you're attending the banquet, please be sure you're signed up for a table at the registration desk. Please only sign up for yourself and your significant other. We've had a few instances of people being registered for multiple tables.

As many of you discovered last night, there will be cash bars available on this level from 11pm-1am after our concerts. #### ABA Business Meeting #1

#### Colburn, Call to Order (10am)

(1) I would ask ABA Secretary/Treasurer Tom Fraschillo to come forward for the Treasurer's Report and approval of the minutes.

*Request motion to approve minutes and the treasurer's report.* 

(2) President reminds/explains the nomination process:

As some of you know, after last year's convention I asked that an ad hoc New Member committee be formed to examine the process of how we identify and evaluate candidates for membership in the ABA, One of the recommendations of the committee was to describe the process in greater detail to our membership, which is what I will now attempt to do.

One of our most important tasks as members of the American Bandmasters Association is to seek out qualified candidates for membership. Qualifications include exceptional ability and accomplishment as a band conductor or as a composer/arranger, commendable personal qualities, including a high standard of professional ethics, and demonstrated leadership ability and service to the profession. To be considered, the name of a nominee shall be submitted by a current member on the prescribed and completed Nomination Form, which can be obtained from Tom Fraschillo up here at the dais. This form must include the signature of a Principal Sponsor who has been a member for at least five years, and should also include the signatures of at least two co-sponsors. The form must be completed and in the hands of the Secretary-Treasurer before the end of the annual convention. The Principal Sponsor will receive guidance from the Vice-President and is responsible for overseeing the process for their respective candidate. Failure to comply with all instructions and/or deadlines will invalidate the sponsorship of a nominee. After all the required materials have been collected and organized, they are made available for our membership to evaluate online, and feedback is

provided through the Candidate Evaluation Questionnaire that you are all requested to complete.

A few more thoughts on the role of a Principal Sponsor: Serving as a Principal Sponsor for a candidate for membership is arguably the most rewarding of any ABA responsibility. As stated in our constitution, a Principal Sponsor should know their candidate well, both personally and professionally, and be well acquainted with a candidate's ensemble through hearing at least two performances, but hopefully many more than that. A Principal Sponsor is also expected to have firsthand knowledge about a candidate's service to the profession, communication skills, and quality of character. In short, one should not serve as a Principal Sponsor unless you have first-hand, personal knowledge of a candidate, and can vouch for them both professionally and personally. If a candidate is elected to membership, the Principal Sponsor will serve as the primary source of information for that new member. This is especially critical immediately after a new member's election, when they are likely to have many questions about what is expected of them as ABA members. Principal Sponsors are encouraged to reach out to new members in advance of their first convention, as there will likely be questions regarding meetings, Significant Others, excursions, banquet seating, and a variety of other singular aspects of an ABA convention. The role of mentor often continues many years beyond that first convention, and Principal Sponsors are encouraged to be a source of advice and counsel to their new members throughout their time in the ABA.

I would also like to take a moment to describe the work of the Membership Committee, as I have often heard questions and speculation about how the committee arrives at its recommendations.

Yesterday afternoon, our officers, board of directors, and Past Presidents assembled to execute their responsibility as the Membership Committee of the ABA. As part of this responsibility, they have access to the same recordings, Sponsor Evaluations, and candidate resumes all of you have when you are completing the Candidate Evaluation Questionnaire. In addition to these materials, they are also provided with a compilation of your assessments, as well as the comments you have offered in your evaluations. Please note that this information is provided anonymously – no evaluator's identity is <u>ever</u> revealed to the Membership Committee. It should also be noted that the Membership Committee has access to this information for several weeks before the meeting, so they have ample time to prepare. After a full discussion of each candidate, a vote is taken to invite or defer, with a requirement for a two-thirds majority in order for a candidate to be invited. The Vice President is then tasked with presenting the report of the Membership Committee for your consideration. It is our hope that this additional information might help inform your vote on the Membership Committee Report.

Please note that there is a more complete description of the membership process in our constitution, which is accessible to all members on our website, and a more detailed description of the responsibilities of the principal sponsor in the materials that are also available on the website.

## President's Charge

In light of our commitment to continually improve and enhance the process of identifying, nominating, evaluating, and electing new members of the ABA, I am appointing an ad hoc committee of ABA members to assess our current practices, discuss possible improvements, and propose specific changes. Topics of consideration may include, but are not restricted to, the following:

-Written guidance for caucuses and caucus leaders

-Instruction for primary sponsors, with special focus on CV and recording requirements -Questions on the candidate evaluation forms - both content and style -How to deal with members who do not evaluate online materials (CV, recordings, etc.) and then participate in voting

-Feedback for primary sponsors of deferred candidates

-Three-year delay before deferred candidates can be re-nominated

## Ad Hoc-Membership Committee Recommendations

#### Pre-Convention/Convention (Caucus and information)

- Provide more transparency at this stage (VP reviews this process in detail from the lectern)
- Write specific information/instructions to caucus leaders (president)
- VP communicates information regarding Nomination Form
- VP communicates how best to serve as a Primary Sponsor
  - Provide to the VP a script of guidance regarding the Nomination Form and Primary Sponsor Form

#### Nomination, Candidate and Sponsor Forms/Information

• Nomination Form has been updated to accommodate technology advances as well as to clarify and define the process

#### **Candidate Form**

- Add to the wording on all documents to "require 60-70 minutes of music, with a minimum of 60 minutes being of one's own ensemble(s) and not as a guest conductor."
  - This will require a change to the constitution
- A March must be included as one of the selections
  - This will require a change to the constitution

#### Principal Sponsor Information/Guidelines

- This form has been updated and approved by the Board of Directors with the intent of using it beginning March 2024.
  - Provides for more clarity
  - *Reflects technological advances*
  - Includes some date changes
  - Includes a statement regarding "one's own ensemble(s)" and possibly a statement about a march requirement/recommendation.

#### **Evaluation Form**

• We are currently using the Board of Directors approved document and will be evaluated after this New Member cycle.

#### Membership Committee

• At the beginning of the MC meeting at the convention, the VP must report the percentage of GM providing feedback

#### **Deferred Candidates**

- Only members who have reviewed the materials may vote on Deferred Candidates
  - requires a change in Constitution and would not go into effect at the 2024 convention)
  - All members may speak on behalf of a Deferred Candidate
  - A deferred candidate may not be renominated until the 3rd year after deferment
  - If a Candidate is deferred, feedback to the Principal Sponsor should be allowed under the following conditions:
    - Feedback is provided only by the VP and at the discretion of the VP
    - Feedback is provided only to the Principal Sponsor
    - Feedback shall not include specific comments (written or spoken) from the MC
    - Feedback must be constructive and intended to help the Deferred Candidate and/or Principal Sponsor

The above information is to be added to the VP's instructions to the MC and to each officers and board of directors handbook.

- Additional Items
  - All documents should be dated.
  - All documents should have the same font.

## **ABA IDEA Committee Report**

The IDEA Committee would like to present the following statement to the Board for consideration. It would be a procedural statement for upcoming conventions.

The American Bandmasters Association (ABA) is resolutely committed to fostering diversity and inclusivity. We recognize the historical disparities and underrepresentation that persist in the realm of concert programming. In your ABA programming, we ask you to include at least one composition crafted by an artist from historically underrepresented backgrounds, specifically Black/African American, Indigenous/Native, Hispanic/LatinX, Asian American and Pacific Islander, and members of the LGBTQ+ community. Additionally, we request the inclusion of at least one composition created by an individual who identifies as female.

This would be a request to the bands, starting with the 2025 convention. We have spoken with some of the band leaders for 2024 (some of them are on the IDEA committee), and it seems that the 2024 performances are already diverse in nature.

## American Bandmasters Association (ABA) Research Center Report

January 2023 – January 2024 John R. Davis, Curator, Special Collections in Performing Arts Michelle Smith Performing Arts Library University of Maryland

#### Staffing

John Davis continues to serve as Curator of Special Collections in Performing Arts (SCPA) in providing leadership in all the repository's acquisitions, processing, and outreach activities.

Hayden Kramer served for a second year as ABA Processing Archivist. A graduate of the University of Maryland's (UMD) master of arts in musicology, Kramer is currently a student in UMD's Masters of Library and Information Science (MLIS) program.

Dr. Jessica Grimmer additionally served as ABA Processing Archivist this year, with the exception of June-August for maternity leave. This month she departed SCPA to join the faculty of the UMD College of Information Studies. Her replacement will be hired in early 2024.

#### **Research Services and Donation Processing**

This year, SCPA has continued the work of collecting, preserving, and making available the records of the American Bandmasters Association. We have taken a special interest in making these materials more accessible than ever before, enhancing online browsing of our materials.

Hayden Kramer received five (virtual) reference questions pertaining to ABA collections, including those of/on Frank Simon, Ernest Williams, Jack Wainwright, and William P. Foster as well as one question regarding the 2004 ABA Convention.

We also continued to engage in outreach efforts to broaden the research center's reach and accessibility. This has included the creation of promotional instructional videos posted on the Michelle Smith Performing Arts Library's YouTube Channel:

Hayden Kramer contributed ABA-related content to UMD's Special Collections and University Archives' (SCUA) blog, which will become an ongoing series (first post featuring the Lynn L. Sams papers). Jessica Grimmer has planned and created content for an exhibit on Gladys Wright's legacy. Grimmer will provide a brief presentation on the ABA Research Center at the annual ABA convention in March.

Processing continues to be at the core of the ABA project archivist position. This year, we processed of 10 linear feet of materials as part of a gift from Dr. Raoul Camus, with materials dispersed into the following ABA collections:

- <u>College Band Directors National Association (CBDNA) records</u>
- Edwin Franko Goldman papers

- Goldman Band collection
- <u>Robert Hoe collection</u>
- Leonard B. Smith collection

Additionally, we have processed of a new accrual to the <u>Robert E. Foster papers</u>, created revisions to the finding aid for the <u>Robert L. Grace collection</u>, including the item-level description of the Recordings series. Key items from the <u>Patrick Gilmore collection</u> were reprocessed, many of which are fragile documents from the late 19th century; revised finding aid at the series level to reflect the diversity of the materials within the collection.

A major project to increase accessibility was the transfer of the ABA recordings database from Filemaker software to <u>ArchivesSpace finding aid</u> undertaken by Hayden Kramer. This project is ongoing, as there are over 4,000 ABA recordings in SCPA's holdings with varying types of metadata. This will make the materials searchable online. So far, 1600+ LPs and 300+ tapes are now accessible for patrons to request through the searchable finding aid.

To improve preservation conditions and increase ease of access, a barcoding and physical rearrangement was carried out on the ABA institutional records. Barcoding and rearranging was also done for the Lynn L. Sams papers; this corrected inconsistencies in the numbering of the collection and improved the accuracy of the online finding aid. Finally, Hayden Kramer undertook a review of the ABA materials in SCPA's oversize documents case and rehousing materials in appropriately sized folders and ensured that the physical holdings were accurately reflected on the online finding aids.

#### Acquisitions

This year we received new accruals to the Robert E. Foster papers, the ABA Recordings collection, the Robert L. Grace papers, and the general ABA records. We have also been working with potential donors within the scope of the ABA to bring in high-impact collections and broaden the diversity of our current collections.

This year, there were several inquiries concerning the Edwin Franko Goldman Memorial Citation and a few Goldman Memorial Citation Nomination Forms were requested and sent. I received two completed Nomination Forms along with supportive materials. All materials were received on or about November 1, 2023.

Dan Turner nominated Quincy Hilliard. Letters of support were received from the following ABA Members: John Carmichael, Les Hicken, David Kish and Alva Kaye Lance. These letters, along with all supporting documents, were sent to the Goldman Memorial Citation Committee Members listed above. All members responded in a timely way with unanimous support for Quincy Hilliard. Unfortunately, Quincy Hilliard's candidacy was declined at the ABA Board of Directors Meeting at the Midwest Clinic in December. No explanation was given to the Goldman Memorial Citation Committee for this unprecedented decision by the Board of Directors.

In addition, Jay Gephart nominated Patrick Sheridan. Letters of support were received from the following ABA Members: Max McKee, Bob Ponto and Mike Golemo. These letters, along with all supporting documents, were sent to the Goldman Memorial Citation Committee Members listed above. All members responded in a timely way with unanimous support for Patrick Sheridan. Jay Gephart plans to introduce Patrick Sheridan to the ABA membership at our March Convention in Washington, D.C. This will be part of the Goldman Memorial Citation report to the membership.

The Goldman Memorial Citation Committee results, along with all supporting materials, were then sent to Tom Fraschillo.

Our website states that the Edwin Franko Goldman Memorial Citation "has become one of the most important continuing projects of The American Bandmasters Association". Going forward, the ABA membership should be encouraged to consider nominating individuals deserving of this recognition. I again plan to ask Tom Fraschillo to send an email to all ABA members in May or

June asking them to consider nominating an individual who has "rendered conspicuous service in the interest of bands and band music in America".

Past awardees have included conductors, composers, arrangers, outstanding instrumentalists, instrument manufacturers, teachers, music publishers and other business and government persons who have made notable and significant contributions. There have been 72 recipients to date. Recent recipients include: Edward Downing (2017), Earle Louder (2019), John Williams (2020), Andrew Balent (2020), Ryan Anthony (2020), Larry Daehn (2021), Scott Schwartz (2022), Philip Smith (2022), Daniel Perantoni (2023) and Frank Byrne (2023).

It is not widely understood by the ABA membership that there can be more than one recipient a year.

The nomination procedure is not complicated, but it does take time to complete. The process begins with the completion of the Goldman Memorial Citation Nomination Form that is available from the Secretary/Treasurer or Goldman Memorial Citation Committee Chair. The Nomination Form should be emailed to the Committee Chair along with letters of support from current ABA members, a brief biography of the nominee, a rationale statement and any other supportive documents for the nomination. All materials must be received <u>in digital form</u> by November 1<sup>st</sup>.

On a personal note, I would like to thank the members of the Goldman Memorial Citation Committee for their timely responses to all correspondence.

# **Mission Statement**

The slightly revised mission statement of the EPC is as follows:

The American Bandmasters Association Educational Projects Committee strives to create and provide resources and programs to connect members of the profession with the most current, relevant, and diverse information. Through these resources and programs, we promote the musical awareness, artistry, and enrichment uniquely associated with the study of music through the medium of the concert band.

# Mentoring

With nationwide concerns about teacher shortage, burnout and attrition, mentoring was one of the projects of the EPC which generated interest among its members. Realizing that mentoring models already exist, the committee looked to programs such as those affiliated with the Iowa Bandmasters Association and National Band Association to determine what could make an ABA mentoring program viable and useful.

What is currently being developed and will be brought to the executive board for approval in the near future is a program that will match interested ABA members with self-selected K-12+ teachers in the field. Rather than trying to identify an ABA mentoring program as unique when compared to other programs, the hope is that adding ABA members' strengths and expertise may be attractive to a broad swath of teachers, perhaps even those with some experience but starting a new phase of their careers (e.g. collegiate) and not always knowing a geographically proximate expert.

# **Educational DVD/website**

This sub-committee is working on developing resources similar to the DVD produced a number of years ago with the Navy Band and Lincolnshire Posy. This project is moving forward but with logistical issues to confront and overcome. With the incredible success of the Navy Band project as a model, it is hoped that some version of this resource can be produced.

# Warren Benson Project and Edwin Franko Goldman Project

Both of these separate sub-committees are pursuing similar tracks in developing richer biographical references and resources on these seminal figures in the band world.

# **Diversity**

The EPC is exploring ways of providing resources on composer diversity and the promotion of underrepresented composers, conductors and musicians in ways that do not duplicate existing resources.

# **Conference Programming Project**

This effort, spearheaded by Mark Heidel, will gather and make available the programs from as many past conventions as possible. Mark is working with multiple sources to create a resource that should be of great historical and pedagogical value to the organization.

## **ABA Significant Other Committee Report 2024**

The Significant Other (SO) Committee has had a busy year. Below is a list of the work that we have been doing.

- The chairs of the subcommittees of the SO committee met three times in October, January, and February.
  - The Biography Subcommittee, chaired by Robyn Chapman, has created a form that we will be sending out to all SOs to update or provide for the first time biographical information that we can add to the work that Ann Bloomquist and Anne Jorgenson started.
  - The Communications Subcommittee, co-chaired by Dee Dee Caneva and Abby Fansler, has accomplished several tasks:
    - Developing a communications plan
    - Setting up a Gmail account for the SO Committee
    - Beginning planning for an SO page on the ABA website
    - Hosting a Convention Information Zoom meeting for members
  - The History Subcommittee, co-chaired by Carol Zeisler and Tracia Austin, helped Beth Kaufman create a memorial for Ann Bloomquist and also arranged for a memorial for Michaeleen Toler. They also put together a display of some of the biographies from the Significant Others Biography book created by Ann Bloomquist.

Chairman of the board, Kerry Taylor, opened the meeting.

The first items of business were the minutes and financial report. The Secretary-Treasurer opened with an explanation of the minutes that were sent electronically to everyone. The Financial report then was given by the Secretary-Treasurer. Each item on the financial report was explained, and a complete report will be given at the next meeting, i.e., through the end of the financial year.

Chairman Taylor asked that we skip to the Convention Report for 2025. Randall Coleman, the host of the convention, spoke on the activities including concerts, excursions, and hotel arrangements. Cohosts (helpers) are David and Cheryl Gregory, Roy and June Holder, and (President 2025) Bobby and Teresa Francis. Concerts will be by the Southwest DeKalb High School Band, Vanderbilt University, Columbus State University, the Alabama Winds, and the United States Army Band, *Pershing's Own*.

Michael Colburn then reported on the Washington, DC convention. The four premier bands are performing on Wednesday and Thursday evenings: the Air Force Band and the Army Band on Wednesday evening with the Navy and Marine Bands performing on Thursday. A combined

band of members from all the Premier groups as well as members of a Japan Ground Self Defense Force Band (sic) will perform on Friday evening at the Constitution Hall.

The excursions are filling quickly in fact, some are already full.

Roy Holder then reported on the 2026 convention possibilities. (Chicago) Those who oversee activities are Brian Covey, Bruce Moss, and Scott Casagrande. There are many venues for concerts; however, the price, plus the location could be a problem, depending on where they are. Roy continued to discuss possibilities.

Bobby Francis asked if there were other possibilities, and Roy responded that Las Vegas had been considered. Tom Leslie thought, however, that everything had become so expensive that the possibility of a convention would be impossible.

Convention discussions continued with various locations for the future: Eugene, Oregon; Madison, Wisconsin; et al. Jay Gephart interjected that possibly mid-size cities would be far less expensive.

Roy Holder was then asked to give an update on the membership report.

Roy's report was generally a thank you to those who had helped him with putting the recordings and curriculum vitae online. He stated that we had extended the deadline for submissions a month. Much of this conversation was inaudible, probably due to the placement of the microphone and Roy's soft-spoken manner.

Chairman Taylor then asked for a report from the Associates. Since Dan Bolin was not there due to health reasons, Bruce Gilkey gave the report. Bruce reported that there were no new members to be brought into the ABA Associates, but the members who had been elected last year would be at the convention. Those members are Mark Harting, Music Travel Consultants; Larry Clark, Excelcia Publications; Boston brass; Pam Smith-Kelly, Claude T. Smith Music; and Edward Lopez, Perform America.

Dennis Fisher was asked to give a report on the SAO award.

Dennis gave some general information; however, he began his discussion with movement of the deadline from August 1 to July 15. This stemmed from the submission of material at the last minute. By moving the submission deadline to July 15, there would be much more time to organize submissions and to send them to the committee.

He gave a handout that he wanted to take up at the convention Board meeting that included much of the discussion. That included submissions from grades I-IV and moving grade IV to grade V.

Kerry Taylor asked if there were a clear delineation used for submissions Grades IV and V. Dennis responded that they had incorporated a template used Carl Fisher. Kerry wanted to know if it would benefit the contest by posting *the template*. Dennis responded that he really did not think so.

Kerry continued by asking if there had been serious consideration given to separating grades I, II, III, and IV, V, and VI.

Dennis responded by stating that many composers were reluctant to write at the lower grade levels, i.e., I and II because they knew that a grade IV would win.

A lengthy discussion ensued. When all finished, it was decided that Dennis would bring a more inclusive proposal to the next board meeting.

Chairman Taylor asked the group to look at the ABA ad hoc committee on new members.

**Committee Members** 

Kerry's report, et al-many members were charged with the work of this committee. The first item discussed was from Jay Gephart. *Caucus and pre-convention*.

Jay stated that there needed to be as much transparency as possible in the process. The document that he had put together was for the caucus leaders. The back of the nominating form states exactly what needs to be done in order to nominate a person for membership.

The next item that he discussed involved submission information on the part of the membership, e.g., the inclusion of a march in the process. He stated that the march was not required. The next item was the vetting of a candidate and his recordings. If a candidate was not known well, by either a sponsor, or a cosponsor, he should not be nominated. The committee felt strongly that this should be adhered to. All this needs to be done in advance. Nothing should be left to chance. The recommendation was that a candidate should be vetted for at least a year. Then the candidate could be brought up for membership.

Further, the primary sponsor should listen to recordings of the candidate, at least two months in advance of nomination in order to be sure that the candidate was ready. None of this should be done between the convention and the submission deadline, March 15.

The candidates supporting materials should be extensive. A traditional résumé is probably not enough.

Cross caucus discussions are encouraged. In the past there has been some reluctance to go to another caucus and discuss a potential nominee.

Finally, the nominator should know the process completely.

Jay suggested that a message go out to the membership prior to the convention (February) discussing the caucus process and whom members should nominate and the process.

A lengthy discussion ensued much of which concerned the inclusion of a March on the recordings. Since several of these issues would require a constitutional change, it was thought that these issues should be brought up in two years.

Jay Gephart said that often issues resolved themselves, e.g., recordings containing other peoples' ensembles, for instance, a candidate might have another group on the recording while they did not have their own ensemble on the recording. The other issue that often resolves itself was the inclusion of literature from a university's primary ensemble and not a candidate's own ensemble.

Next item of business.

Nomination forms and candidate sponsor forms: Bobby Francis. Paul Popiel and Mary Schneider were members of the committee.

Bobby began to discuss his hand out.

He passed out two documents, one that goes out from the primary sponsor to the nominee, and the second document was one that was sent out to the nominee by the principal sponsor with instructions on when to submit recordings, CV, etc.

He discussed items on the documents which were overlapping. The first was, do we want to ask for the home address, the University, or school address. It was thought that we need to ask for the home address. That which was taken out was the birthdate. Included were employment years and educational years. Those were included so that those looking at the document could see gaps that might be suspicious. Added were significant performances and a discography. Also added were significant online publications in order to modernize the document.

Also, added was a bullet point for professional honors and awards. The thought was that people could look back 20 years into one's career.

Questions and comments followed.

Kerry Taylor commented that one of the items that we had discussed was not in this proposal, the 60-70 minutes of music. He would like Board approval. It was moved, seconded, and approved.

Other items discussed were the dates for submission and letters sent by sponsors. It was decided that the dates remain the same for the first two submission dates, i.e., May 15 and July 15.

A lengthy discussion ensued; however, it was finally decided to leave these documents, with modifications, as they are, or as they were formatted for this meeting. Those modifications came under the area of clinics/presentations.

Kerry called for a motion to approve these documents with modifications. Someone so moved and another seconded. The voices were inaudible.

The evaluation form done by Linda Moorhouse has been used; however, we have not had Board approval. Kerry Tyler asked for Board approval. Someone so moved and the item was seconded.

Michael Colburn brought up the work by a subcommittee on a member's ability to vote for a candidate if the member had not listened to the recordings and read the documentation. This would require a constitutional amendment, i.e., Section III paragraph g. It was decided that this year would be a voluntary program. The amendment then will be voted upon the following year. Members would be left to their honor this year.

It was moved and seconded to approve the proposal. Jay Gephart proposed that this year we not softball this but keep the proposal relatively quiet.

The proposal was voted on and approved.

Michael Colburn's second item was the understanding of members of the membership committee and what goes on behind closed doors. He had drafted a statement to be read did the membership by the President. The statement should be read by the President in the meeting prior to the voting on perspective members. Michael had drafted the following:

Yesterday afternoon our officers, Board of Directors, and Past Presidents assembled to execute the responsibility as the membership committee of the ABA. As part of this responsibility, they have access to the same recordings, sponsor evaluations, and candidate resumes that all of you have in the evaluation process...

The statement had clarity and should be understood by all.

The last item was feedback on deferred candidates. Feedback will be provided to the principal sponsor only, divulging no one's comments on the membership committee. The feedback will be given by the Vice President only and only to the principal sponsor.

Kerry Tayler felt that since this was a public item, that we should have a motion to approve. A motion was made and carried.

New Business:

The reflections committee.

Robert Smith had presented this project last year at the convention; however, his untimely death had not provided him the ability to see it through. Steve Moore had made an excellent video that is online on the website. A letter will go out to the membership upon our return.

The School Bands' Committee - Roy Holder

Roy's main concern was how do we disseminate the information that the ABA has collected to the general Band population. Kerry Taylor asked if he would possibly put together a short survey for our membership and the Board.

Jay Gephart said that our Social Committee needs *to step it up* in that we have a lot of growth to make in that area. All of Roy's information could go on the Social Committee site rather than just on our website.

Chad Kamei is one of the cochairs of the Social Committee, and he had reported that there had been over 500,000 people involved in the information disseminated on our Facebook page.

#### Goldman Citation

There were two candidates, one of which was voted down, and one of which was accepted.

Quincy Hilliard – did not pass – Dan Turner was the principal sponsor Patrick Sheridan – passed – Jay Gephart was the principal sponsor

#### ABA Research Center

Richard Miles oversees the committee and has done extremely good work. One item that was on the agenda was to raise the commitment of \$9000-\$10,000 to help support the archivist. A motion came forth to approve the extra thousand dollars and was approved.

#### **Education Projects Committee**

Kerry stated that they have done an excellent job. One could see at the bottom of their report that they have revised their mission statement. No action was taken because none was needed.

#### IDEA Committee Report

The committee had written a report including a statement to be given to every performing group at a convention. Each group is requested to perform a work by an underprivileged composure and a person identifying as female composer. Rebecca Phillips felt the timeline for concert duration is too short to require two pieces. Much discussion ensued.

It was decided to table this item until the next meeting.

The meeting was adjourned due to the meeting room's need for another group.

#### Adjournment

Dennis Fisher was asked to give his recommendations for the Sousa/ABA/Ostwald Award. The first recommendation that Dennis brought forward was redaction of names of composers. All seem to agree that this was important. The second item was the submission of MP3 recordings. Dennis explained that submission of many of the MP3's probably had to do with the pandemic and the lack of performing groups. The consensus in the committee was that a midi recording certainly was not acceptable, for a computer can play anything.

One concern above all others was the number of submissions. This last year we had approximately 40 with a good number of those being grade IV. (sic-Which as we all know is a grade V in sheep's clothing.) How do we recruit composers to write in that level? If we put the IV category in with the V-VI, then the number of submissions would be totally unwieldy.

Pres. Gephart asked if there had ever been any consideration in making the contest a I through III?

A lengthy discussion ensued with Dennis pointing out several salient factors that the committee had discussed. (e no.g.-making the contest a I-II, III-IV, V-VI.)

President-elect Colburn asked if Dennis were going to do the reductions himself or if he was going to use a program to do so. Dennis responded that he would do so. Colburn responded that this could be a very time-consuming process. Dennis explained how he would do the reductions.

President-elect Colburn brought up the idea of funding for the I-II, III-IV, V-VI. Pres. Gephart then explained how the contest was funded.

A rather convoluted discussion ensued, for example Dennis brought up the idea of members wondering if these pieces were played by our members.

Pres. Gephardt finally asked for motion to support the first two items on Dennis's agenda, e.g., the redaction of names on the compositions and the use of Midi recordings. He asked that we table the third one, i.e., the reorganization of the contest (I-II, III-IV, V-VI).

Kerry Taylor asked if Jay would entertain the idea of separating the above. He said yes, and Kerry Taylor moved that we consider the reduction of names from the works submitted.

He so moved and Linda Moorhouse seconded.

Discussion ensued with Pres. elect Colburn if this were to be for a trial or forever. The question was not answered, but it seemed to be the consensus that it be on a trial basis.

Mark Heidel brought up that if a work was submitted without redactions, that the composer be disqualified. To which Dennis remarked that one could call the composer and ask them to remove their name.

The motion passed without objection.

Robert Smith gave a lengthy discussion on the MIDI recording and how it can often produce sounds, ensembles as relevant as a band.

Chairman Gephart suggested that we send this back to committee and let them decide for the December meeting how they want to proceed.

Tom Fraschillo, Secretary-Treasurer was asked to then give the minutes and the financial report. No comments or questions regarding for the minutes; therefore, a motion was call for by the president. Bobby Francis moved that the minutes be accepted, and a second was given by someone whom I could not hear on the recording.

He then gave the financial report consisting of all categories including the Harris Fund, the Money Market Account, and the Checking Account. The question was raised as to whether we are at the appropriate level or should we be looking for more. The answer was that we are in far better financial status than we have ever been.

Motion was call for and Bobby Francis so moved with a second by someone whom I could not hear the recording.

Randall is not at the convention yet, but Chairman Gephart reported that we were at the Westin in downtown Chattanooga with lots of restaurants available.

VP Bobby Francis was asked to comment, and he gave a description of several excursions that seemed inviting. The performance venues were the University of Chattanooga concert hall and several other venues that were available

for the Friday night concert. One Friday night availability for the military band would be the Ringgold High School Performing Arts Facility.

Chairman Gephart asked if he had performing groups selected, and he responded that some had been given consideration but had not been selected.

Paul Popiel was then asked to report on the ongoing Kansas convention. He stated that there were 258 registered for the conference with 162 members and 106 spouses, significant others, and 205 registered for the banquet. He stated that one of the things that was very expensive for the convention was coach costs, \$2000 for one run; therefore, they had put a significant amount of energy into having excursions that were on your own kinds of things.

President-elect Michael Colburn was then asked to give a report on the Washington, DC, convention. He stated that he had begun talking to the commanders of the four military bands who would be participating. Since it was going to be a very expensive convention, he had begun to do work on the financial support of the convention.

He stated that Andy Esch had retired from the Army Band and that Bruce Pulver had been appointed the new commander. Since Bruce had never hosted a convention or been a part of one before, he had asked Andy to stay on as a cohost which he agreed to do so. The same with Jason Fettig who was leaving the Marine Band; therefore, he had asked the new conductor Ryan Nowlin to be a cohost. Both have agreed and would be supportive in their roles as new conductors.

A great hotel with a rate of \$179 per night. It is the Renaissance Arlington Capital View. The concerts site for Wednesday and Thursday will be the Rachel M. Schlesinger Concert Hall and Arts Center with the Friday night concert at DAR Constitution Hall. The Friday night concert will consist of members of all bands including the United States Coast Guard Band members. Constitution Hall was built the same year that ABA was founded, 1929. It was the site of the 1932 convention featuring the Army Band, Navy Band, and the Marine Band. There was no Air Force Band at the time.

We will be premiering the very first IDEA committee commission, a work by Kevin Day. Other bands will be premiering new works probably by Jim Stephenson. Excursions will be the Smithsonian and the Library of Congress.

VP Bobby Francis was asked to give a membership report. He stated that we would move forward with 20 candidates today while we had begun with 22. There were 23; however, one was withdrawn for insufficient materials and to others were withdrawn. He wanted to thank Dr. Linda Moorhouse for her help with entering the materials, recordings on the website. No one realizes the amount of work that she puts into this; therefore, we should all give her a big thank you.

Pres. Kerry Taylor then introduced board member Robert Smith's report on what we to do as a body about gun violence in America. He thanked the committee would work on the project. Lowell Graham headed the committee.

The committee worked tirelessly to come up with a statement that could be read at a public gathering in order to bring awareness an hour those who had been taken from us through gun violence.

He read the American Bandmasters Association reflections committee statement.

In the midst of life's most challenging events it is important for us to look both inward and outward. To reconnect with that universal voice, that voice that ties us together as humans living and growing in a single world. That world is our gemstone with many facets, yet when we focus with greater vision, we see the larger entity the priceless gem call life. Let's raise our voices to remember our past, honor our present, and express hope for our collective future. One world, many voices, and a symphony of song.

That statement was sent out as a call to composers to write an underscore for the above. Four had responded including Robert. He had written an underscore for the Troy Band to be used as a football game honoring military personnel.

Other composers were Dana Wilson, Robert Sheldon, and Thomas Duffy. They had written underscores at various grade levels so that a junior high band as well as a high school band or university band could play them. The United States Air Force band had finished a recording of all the underscores. Robert stated that one other composer Brian Balmages was also Riley an underscore.

The text had been translated into multiple languages, e.g., Russian, Italian, Spanish. Robert thanked Lowell Graham for his leadership.

All were very impressed, and Chairman Gephart thanked Robert for his work.

Old Business

The IDEA committee commissioning project had received funding from the Foundation, and you should have received a memo from Tom about contributing to the further funding. If funding does not meet the goal, then we can approach the Foundation again; however, Chairman Gephart suggested that we wait.

Roy Holder was then asked to give a brief report on amplification within marching band. Roy stated that he had formed a committee of ABA members and have some band directors outside of ABA. He stated that it had come to his realization that we should state that which we were for before we did anything else. He had found that many band directors were focusing on solely marching band and not those things that we should be focusing on as music educators. He stated that we need to put together ABA, the Sousa Foundation, NBA, ASBDA and all other organizations to make an impact. DCI had not made changes; however, Bands of America had. He stated he did not know what the outcome would be, but that if we did not do something, the profession would be in trouble.

Roy was thanked for his work.

Pres. Taylor then brought up the need to approach University programs as well as public school programs, for we have a problem there as well.

Chairman Gephart then brought up the idea that Roy should bring on board some of the large band director organizations, e.g., the Big Ten Band Directors organization, the SEC Band Directors Association, the Big 12 Association.

Robert Smith brought up the influence of indoor drum line, indoor band, and other activities there were taking away from the concert band. Roy agreed and alliterative some of his experiences.

New Business

New member application process.

Dr. Moorhouse gave a lengthy explanation of the nomination process and how it has evolved. She stated that now many of the members of the nominating committee do not vote; therefore, the process needs a complete examination. Bullet points were given for the nomination form.

Board member Steve Moore remarked that it is almost like admissions in that the application should be so good that one should not be turned down. Then he remarked that possibly a number of our members have aged out of technology, in that many people use their phones instead of a computer. He posed this remark in the form of a question to Dr. Moorhouse.

A lengthy discussion ensued, including why people have been overlooked for membership. Dr. Moorhouse stated that if we wanted to keep the membership process the way that we had been doing, then we should; however, she thought that we had definite reasons for revising our system. For example, why couldn't we have a committee that scours the entire country for new members.

President-elect Michael Colburn remarked that while we wanted the highest standards in the membership that we should try to cast the widest net possible. We should include all members of our society. He emphasized once again about the lack of membership in Northeast simply because of the lack of bands in the area.

Chairman Gephart suggested that we use the rubric provided by Tom Palmatier some years ago. It would be a change in the way we now evaluate candidates, but it would give us a much better evaluation.

Dr. Moorhouse further stated the case for the principal sponsor being responsible for the best possible recording available from the group. The principal sponsor must gather the information from the candidate as best he/she can.

Chairman Gephart said that now we are requiring all groups to be evaluated the same, middle school, high school, university, and military.

In the total mix Pres. Taylor stated that he personally liked the idea of the rubric. This discussion continued. Dr. Moorhouse stated that no one should be allowed in the room that had not voted.

The discussion concluded with Chairman Gephart asking for a vote on bullet points submitted by Dr. Moorhouse. They were one, two, four, and five.

Someone so moved and the motion was seconded. The motion passed.

Bullet number three, as discussed previously, i.e., the number of years on the recording being five. A lengthy discussion ensued, for in the case of a military band this may be a very different situation. In the case of a junior high band or high school band, likewise.

It was decided to vote on bullet point number three. VP Bobby Francis so moved, and Pres. Taylor seconded.

Chairman Gephart they noted that this would have to be passed at this convention.

Chairman Gephart then brought up the duties of officers and Dr. Moorhouse's having placed these on the website. She noted that they were under MORE with the passwords Taylor 2023 and Colburn 2024.

Finally, the Foundation audit will not take place at the convention but will be held via Zoom prior to the convention. The Foundation meeting will take place on Thursday afternoon. Chairman Gephart further recommended that the board meeting begin at 9 o'clock rather than 10 o'clock to give us more time between this meeting and the nominating committee meeting.

Finally, before adjournment the discussion was had about the five members would not pay dues. Pres. Taylor had been in touch with these members and had been assured that they would pay.
